Dear Friends of the Crystal Judson Family Justice Center:

It is with pleasure that we provide you with our 2015 Annual Report. Assembling the information you will be reading on the following pages provides us with an opportunity to reflect on our work and the events of the previous year. Evaluating our successes as well as our challenges is critical to ensuring that the work being done at the Center is meeting the needs of the people we serve.

Since first opening our doors in December of 2005, we have been using feedback from client exit surveys and client focus groups as well as input from the advocates who work at the Center to assess the value/effectiveness of our programs and services. This work is guided in large part by these Family Justice Center Guiding Principles (developed by the National Family Justice Center Alliance):

Safety-Focused: Increase safety, promote healing, and foster empowerment through services for victims and their children

Victim-Centered: Provide Victim-centered services that promote victim autonomy

Culturally Responsive: Commitment to the utilization of culturally relevant service approaches that are measurable and behavior based

Intervene and Prevent: Engage all communities through outreach and community education

Survivor Driven: Shape services to clients by asking them what they need

Transformative (willing to change): Evaluate and adjust services by including survivors input and evidence-based best practices

Client Services

Offering a quiet, safe location for victims of domestic violence and their children, the Crystal Judson Family Justice Center provides wrap around services for clients to meet their unique and individual needs. These services include:

- Domestic violence education
- Civil legal services
- Victim support in criminal cases
- Protection orders
- Access to financial services from DSHS
- Spiritual support
- Assistance from Prosecutor's Office
- Safety Planning
- Support groups and counseling
- Sexual assault information
